Resolution #8 Establishing a Consolidated Water Rate

Introduced by: Supervisor

WHEREAS, The Chazen Companies has recommended to the Town Board in the attachment hereto that a uniform rate be established for the Town's operation and maintenance of the operating systems in Water Districts Nos. 1, 3, 4, 4 ext. 1, and 5 and outside service connections within Town limits; and

WHEREAS, the recommended uniform rate is \$2.95 per 1000 gallons, which would include funds for an operating reserve but not for an emergency reserve, a capital reserve, or for the cost of the water being purchased;

Now, therefore, be it

RESOLVED, that the Town Board hereby establishes a consolidated operations and maintenance ("O&M") rate in the amount of \$2.95 per 1000 gallons for Water Districts Nos. 1, 3, 4, 4 ext. 1, and 5, and all outside service connections within Town limits effective April 1, 2013.

Cherkosly at an estimated cost of between \$400.00 and \$800.00 to review and critique PNL's appraisals, \$400.00 - \$800.00 to prepare questions for use at trial, \$400.00 - \$800.00 to review and prepare prior to trial and \$150.00 per hour for pre-trial meetings, trial appearance and travel;

Resolution #10 Establishing a Policy and Allowing Empire Warehousing Corp To Pay GEIS Fees in Installments

WHEREAS, Empire Warehousing Corp. will be submitting an amended application regarding the Esplanade property located on Route 4 and 32 on the border of both Stillwater and Mechanicville; and

WHEREAS, the Town Board has previously adopted a policy permitting developers to provide Town residents with valuable projects and services of equal value in lieu of paying GEIS fees; and

WHEREAS, the Town Board wishes to encourage businesses to locate in Stillwater by permitting them to pay fees required by the Town-wide GEIS in three (3) installments;

Now, therefore, be it

RESOLVED, that the Town Board hereby declares that developers incur the obligation to pay the entire amount of GEIS fees upon filing their initial project-related application with the Town and within no more than 3 years; and be it further

RESOLVED, that the Town Board hereby adopts a policy allowing developers, on a case-by-case basis, to pay project-related GEIS fees in up to three (3) installments, with one-third due when the first project-related application is filed, one-third is due before the first building permit is issued, and one-third is due before a Certificate of Occupancy is issued; and be it further

RESOLVED, that Empire Warehousing Corp. be permitted to pay its project-related GEIS fees in up to three (3) installments as specified in the policy set forth above for the Esplanade project.

WHEREAS, lending institutions that hold mortgages on said vacant structures do not always provide the contact information of a responsible party; and

WHEREAS, Assembly Bill A.88 and Assembly Bill A.824, currently pending, would make it mandatory for lending institutions to provide contact information of responsible parties regarding vacant structures; and require good faith in obtaining a foreclosure; and

WHEREAS, the Town of Stillwater Town Board supports the passage of said Bills;

Now, therefore, be it

RESOLVED, that the Town of Stillwater hereby supports the passage of NYS Assembly Bills A.88 and A.824 and respectfully requests that the State Representatives who represent constituents in the Town of Stillwater support the passage of said Bills.

- 1.No one under the legal age limit of 21 years old will be served any alcohol;
- 2.No one who is visibly intoxicated will be served any further alcohol;
- 3. Anyone who appears even slightly intoxicated, or whose ability to drive in any way appears to be impaired by alcohol, will not be permitted drive a vehicle on or from the premises;
- 4.The SACC and Library will sign a Indemnification Agreement holding the Town harmless from any property damages or personal injuries arising out of its service of alcohol on the Town's property; and
- 5.The SACC and Library will provide the Town with a certificate of liability insurance in a coverage amount of no less than \$1,000,000.00 listing the Town of Stillwater as an additional insured.

Supervisor Kinowski stated that it only included an increase in the O&M.

Councilwoman Whitman announced that the Town Wide Clean-up will be on April 27th. There were no dates available in May this year with County Waste.
