Supervisor Kinowski called the Business Meeting to order and led everyone in the Pledge to the Flag.

Sue Cunningham, Town Clerk took the roll call.

<u>Adoption of Minutes Motion</u> by Councilman Petronis and seconded by Councilwoman Bruno to adopt the minutes of February 2, 2012 agenda meeting. <u>Motion carried.</u>

Communications:

Supervisor Kinowski reported on a request he received from the Mechanicville/Stillwater Chamber of Commerce requesting support for the annual duck derby. It was also suggested that having the Farmers Market at this event to help promote the market. Supervisor Kinowski reported that Family Day will be held on June 1st & 2nd. A date needed to be made since vendors were already calling for applications. Discussion was held on the possibility of purchasing a 20 x 20 tent for town events. Supervisor Kinowski stated that he will look into costs and report back to the Town board.

<u>Past Employees:</u> Councilman Petronis requested a resolution for the next meeting to purchase a Blockhouse brick in memory of Dominick Funaro for past dedication to the Town.

<u>Town Newsletter:</u> Supervisor Kinowski reported that the Town newsletter will start going out next week.

NYC Training: Supervisor Kinowski reported on classes attended while at the conference. One in particular will possibly result in an amendment to the Town budget. He learned that they cannot establish a contingency fund in Highway so this will have to be moved to capital projects.

<u>Van Ness Rd:</u> Supervisor Kinowski requested the Attorney draft a separate engagement letter in case of eminent domain issues.

<u>Blockhouse Committee:</u> Supervisor Kinowski commented on the committee that was formed to move the Blockhouse and whether as a committee appointed by the Town are legally able to own a checkbook from donations given to the Blockhouse.

Discussion was held on whether the Town can authorize judiciary money be held by a committee, whether a Friends of the Blockhouse should be formed or continue as a committee and have the monies funneled through the Town.

Attorney for the Town

Attorney Trainor reported that the Town was successful with an Article 78 filed against the Town regarding an assessment benefit unit reduction. The case was dismissed.

Resolutions #14 Authorizing the Chief of Police to Hire a Police Officer

Resolution #15 Authorizing Engineering and Legal Services In Connection With Repair and Design of Van Ness Road

WHEREAS, the attached Engagement Agreement of The Chazen Companies for engineering services and the attached legal cost estimate of Cutler, Trainor and Cutler, LLP in connection with stabilization of the Van Ness Road Project are annexed hereto and made a part of hereof; and

WHEREAS, these services are needed to acquire easements, licenses or rights-of-way and design and administer necessary repairs to stabilize Van Ness Road;

Now, therefore, be it

RESOLVED, that the Town Board hereby authorizes The Chazen Companies to perform the engineering services and for Cutler, Trainor and Cutler, LLP to perform the legal services described and estimated in the attachments hereto.

Public Input

Russell B submitted the following questions regarding the proposed water line to be recorded in the minutes.

I would like to be provided with the list of names and addresses of those people who have approached the Town Board to request that this water project go forward; and a list of those who have stated that they are not interested in a water line to their property(s). Can you provide me with that information?

Supervisor Kinowski stated that there was no list.

What is the total cost of the proposed "new water line" for County Road 75, VanNess Road, McDermott Road, Elmer Robinson Road and George Thompson Road? Supervisor Kinowski stated that they are still reviewing cost and when they are known the information will be available to everyone.

What are the engineering fees for this project? Engineer Lanaro stated they it is approximately 10% of the cost.

What are the legal fees for this project?

Attorney Trainor stated that he did not have the figures in front of him but it is approximately 5% of the cost.

How is the benefit unit defined for this project? (i.e. house and lot; vacant land?) Engineer Lanaro stated that it is the same benefit unit process used for water district 3 & 4 with a series of formulas.

What will be the cost per benefit unit?

regarding the debt balances.

Engineer Lanaro stated that they only have preliminary numbers but there is a possibility to consolidate all districts which will lower the cost.

What is the total number of benefit units that will be in the new water line? Units in the New Proposed Area
Supervisor Kinowski stated that he is unsure of the number at this time.
Is it correct that you plan to include the debt currently owed by the Districts #3 and #4 residents, to be added into the total cost of the new water line and require residents of Districts #1, #3 and #4 and newly effected residents to pay this debt?

It was stated that they are unsure of the numbers at this time. They have had workshops for water district #1 and the proposed new area. They have not set a date for a workshop
for water district 3 & 4.

Supervisor Kinowski stated that after the meeting he can make available all information

How much has it cost the taxpayers in the Town of Stillwater in legal fees and matters regarding the lawsuits brought against the Town by residents of District #4, to date? Attorney Trainor stated that he did not have these numbers before him this evening.

Will you, as a Town Board, bring this proposal to the residents of the effected areas for a "weighted" (per benefit units) public vote?

If you will not bring this matter to a public vote, how many signatures would be required on a petition to have this matter put to a public vote by the effected residents?

What is the time-frame requirements, and any other requirements that we would need to know to file a petition? (i.e. special language, etc.).

Supervisor Kinowski stated that prior to any decision being made all information will be provided to residents involved and all comments or correspondence form the residents involved will be taken into consideration.

Attorney Trainor went over the legal requirements for the proposed district and there are four ways the Town can go with a different formula to follow.

Supervisor Kinowski stated that all this information will also be made available.

Tony B inquired if grant money was reflective in the 10% quote to construct the water line and the length of time expected to put in the proposed water line.

Engineer Lanaro stated that grant money was not reflected in the 10% quote. He said that the quote covered things such as design, easements, reviews and it would take an estimated time of two years to complete the entire process.

Tony B commented on the property values for water district 3 & 4 increasing already so what do the residents in district 3 & 4 have to gain by this new district? He also inquired if the hook up fee was going to be waved.

Discussion was held on the hook up fees from the main to the edge of road being waived but from the edge of road to the home the resident would be responsible.

Supervisor Kinowski spoke on the concerns the Town has with supplying water to the Town residents. Water District #1 is now supplied by the Village and their water source is the County water system but district #3 & #4 are supplied by the City of Mechanicville who has possible problems with their reservoir & dam problems.

Coke C inquired about the number of homeowners easements have to be obtained for Van Ness Rd being repaired and commented on low water pressure last week and not being informed of any problem.

Attorney Trainor stated that approximately 7 seven easements have to be obtained. Supervisor Kinowski stated that no one called to inform him there was a problem. He found out on Tuesday that there was a problem.

Councilman Petronis stated that there was a break in the line going up to the tank in Hillside.

Art F commented on the water line in Water District #4 being extended up Van Ness Hill, at the last minute and benefit units.
