Supervisor Kinowski called the Business Meeting to order and led everyone in the Pledge to the Flag.

7:00 PM Public Hearing (Zoning-Route 67-west)

Supervisor Kinowski called the public hearing to order and led everyone in the Pledge to the Flag.

Paul Cummings of the Chazen Companies gave a brief overview of the proposed Route 67 Business District. He went over the project background, Route 67 Comprehensive Plan Vision, Route 67 Comprehensive Plan recommendations, existing land uses, exiting zoning, existing topography, existing environmental resources; Route 67 overlay district, Route 67 Business District, proposed uses and the next steps for the Town.

Public Input

Art F inquired about the wetlands & reservoir and how they would be protected. Supervisor Kinowski stated the areas would be protected and buffers would be put in place.

Diane S of Malta stated that her home is in part Malta and part Stillwater and she has concerns with traffic, safety, property values going down and the effects to wildlife and residents. She also inquired if a Title 1Action-Environmental Impact was completed Paul Cummings stated that a full impact SEQR has been done. Further discussion was held on the SEQR process and where filed. It was stated that the appropriate forms were done and filed.

Attorney Trainor stated that the use of property as it is now remains the same, future use depends on the change.

Engineer Lanaro commented that her home was regulated by Malta and the proposed zoning changes will have no effect on her assessment.

Al D stated that he bought a vacant lot next to his home and wanted to know how these changes would affect him being able to build there later on.

Paul Cummings stated that he would need to apply for a use variance.

Supervisor Kinowski stated that they are hear to comments from residents and will try to accommodate their concerns.

A resident inquired if they are being driven by a commercial adventure. Supervisor Kinowski stated that a company bought land from the Sweeney farm, and a SEDC received a grant to look at property of large landowners in this particular area.

Art F questioned the properties in the proposed area would no longer be residential use. Discussion was held on options the residents such as the ZBA, mechanisms in place for residents, PDD process, and rezoning requests.

Diane S inquired if it was possible to file to have property remain residential. Supervisor Kinowski stated that they can clean up the rezoning line so that it doesn't go through her property.

Carol Marotta, Planning Board member commented that the proposed rezoning changes have to go before the Planning Board for review and their recommendations. She stated that moving the line is an easy fix, buffers are a requirement in zoning and storm water regulations have been tightened. Inter-Modal is here and traffic will only grow. The Town needs to be proactive which will benefit the Town.

John V questioned the SEQR process on the prior Route 67 changes. Supervisor Kinowski stated that everything was approved and completed legally.

Jim K inquired about the proposed uses.

Engineer Lanaro stated an applicant would file for a special use permit, come before the Planning Board who can make conditions depending on the request.

A resident questioned the effects on the Tenendoha Creek.

Engineer Lanaro commented that all water and wetland areas are regulated by the State and prevention measures must be followed.

A resident questioned Route 67 becoming a 4 lane highway.

Engineer Lanaro stated that it is a State road but there are no plans to make it a 4 lane highway that he is aware of.

Lisa D asked what was in this for the residents.

Supervisor Kinowski stated that they needed to build a balance in the Town in Residential & Business. Residential has more of an impact on the residents. More homes mean higher taxes where business can relieve the tax burden placed on residents.

Councilwoman Bruno commented that communities around here are growing and reaping the rewards. If the Town doesn't look to the future they will be left in the dark and people won't be able to afford living here anymore.

With everyone having the opportunity to speak Supervisor Kinowski closed the public hearing at 8:20 PM.

Supervisor Kinowski stated that the Town Board would be voting on this at their May 19th meeting after the Planning Board meets. At this time they would go over any changes that are made.
