WHEREAS, the purpose of the hearing will be to inform the public, to determine and consider the need and location of the proposed acquisitions, to review the public use to be served, and to assess the impact of the acquisitions on the environment and the residents prior to acquisition of those properties; and

WHEREAS, the proposed acquisition map and design report are available for public inspection at the Town Clerk's Office during regular business hours and the list of parcels containing the proposed easement to be acquired is attached hereto;

Now, therefore, be it

RESOLVED, that a public hearing be scheduled for Thursday, June 20, 2013 at 7:05 p.m. at the (new) Stillwater Town Hall, 881 Hudson Avenue, Stillwater, NY 12170, to inform the public, determine and consider the need and location of the proposed acquisitions, to review the public use to be served, and to assess the impact of the acquisitions on the environment and the residents prior to acquisition of those properties; and be it further

RESOLVED, that all persons having an interest in the acquisitions are to be invited to attend the hearing or give oral or written statements and to submit other documents concerning the proposed acquisitions that evening; and be it further

RESOLVED, that the Town Clerk is directed to publish in the Daily Gazette and the Express, the notices required by Section 202 of the Eminent Domain Procedure Law for the hearing at least ten (10) days but no more than thirty (30) days prior to the Public

Hearing by publishing in 5 successive issues of a daily paper and two (2) successive issues in the Town's official weekly paper; and be it further

Supervisor Kinowski stated the excavator would be used water drainage issues, retention ponds and multiple other projects. Water district #3 & #4 along with all other water districts would become #6. The SLA controls the water levels of Saratoga Lake.
