Supervisor Kinowski called the Business Meeting to order and led everyone in the Pledge to the Flag.

<u>Adoption of Minutes: Motion</u> by Councilman Petronis and seconded by Councilwoman Whitman to adopt the minutes of the May 3, 2012 agenda meeting of the Stillwater Town Board. <u>Motion carried.</u>

Communications: Two communications were read by Supervisor Kinowski. A thank you from the Kinisky Family for flowers and a correspondence from Assistant Vice Principal John Powell regarding Reality Check Program that deals with the dangers of tobacco.

<u>Reports</u> (Town Board & Department Heads)

Supervisor Kinowski

<u>Riverfront Park:</u> Supervisor Kinowski stated that he would be meeting with the railroad to discuss exchange or services regarding the park property on Tuesday if any Board member wanted to attend. He also stated that they will be teaming up with the National Park services on a grant where the Park Service will be putting in a boat launch next to the Town property.

Councilman Baker

<u>South End Sidewalk:</u> Councilman Baker inquired on the status of his request to repair the sidewalk at the north end of town.

Supervisor Kinowski stated that this was briefly discussed at the last capital projects meeting. At this time it is Supt Minick's hands.

Supt Minick stated that because of the area it will not be able to be done to the Town's Specifications.

Councilwoman Whitman asked when they could anticipate this being done. Supt Minick stated hopefully by the fall.

Discussion was held the sidewalk being flush with the blacktop, cost and easements.

Councilman Petronis

<u>Moolah Hill:</u> Councilman Petronis brought up Moolah Hill for discussion. Supervisor Kinowski stated that the area would need to be resurveyed along with the Town Board deciding intentions and future options for the area.

<u>Family Day:</u> Councilman Petronis commending everyone involved for a great job. Supervisor Kinowski stated that in spite of the rain it turned out to be a success and did not receive any negative comments. He also informed the Board member that he did extend the time for the pony rides and clown due to the weather earlier in the day.

<u>Gurba-Park:</u> Councilwoman Bruno stated that she has had residents in the area question if the small park could be revised.

Supervisor Kinowski stated that at some point they may resurrect that park.

Councilwoman Whitman

<u>New Town Sign</u>: Councilwoman Whitman requested that the Highway Dept. trim around the new sign on Route 67.

Supt Minick informed the Town Board that trimming around the sign was already. <u>Day at the Races</u>: Councilwoman Whitman reminded everyone that August 19th is Day at the Races and the price is \$29 with a deadline of August 4th.

<u>Concert in the Park:</u> Councilwoman Whitman stated that there will be a Concert in Blockhouse Park on July 26th from 6:00 PM to 8:30 PM.

<u>Street Lights:</u> Councilwoman Whitman stated that she called the Electric Co to report street light out but was told in the future they can be reported on the computer now. <u>Summer Meetings:</u> Councilwoman Whitman confirmed that in July and August the Town Board would only meet on the Thursday of the month.

Superintendent of Highways (Mark Minick)

Supt Minick gave a brief overview of work being done by the Highway Dept. and reported that letters are going out to the last few residents who have to have the new water meters installed.

Town Clerk (Sue Cunningham)

Sue Cunningham, Town Clerk informed the Board the Town Clerk monthly report was in their mailbox for review.

Agenda Items (Resolutions #48--#50)

Resolution #48 Provide Maintenance to the Blockhouse Museum Property

WHEREAS, the historic site of the Stillwater Blockhouse Museum requires property maintenance, such as cutting and removing trees/shrubs along the concrete wall and repairing areas with fill dirt, seed, fertilizers and straw coverings; cutting and removing all trees/shrubs near top walkway; providing an assortment of plantings, mulch and plant fabrics; and

WHEREAS, three proposals have been solicited for the required work with the lowest most responsible proposal received from River's Side Yard in the amount of \$1,651.00;

Now, therefore, be it

RESOLVED, that the Supervisor is hereby authorized to enter into an agreement with River's Side Yard to complete the required work at the historic site of the Stillwater Blockhouse Museum at a cost not to exceed \$1,651.00.
