Supervisor Kinowski called the meeting to order and led everyone in the Pledge to the Flag.

Barbara McManus, Deputy Town Clerk took the roll call.

Supervisor Kinowski introduced Matt Jones as Attorney for Global Foundries. Attorney Jones explained the purpose of the meeting was to explain the SSEFIS that was accepted by the Town of Malta on July 29, 2013. SSEFIS stands for Second Supplemental Environmental Final Environmental Impact Statement.

Global Foundries is seeking amendments for Fab 8.2. Amendments include:

Expansion of the building to 575,000 sq. ft.

Increase in the size of the clean room size to approximately 475,000 feet.

Increase of roof stack heights to 125 feet.

Substitution of six traffic mitigation measures in the Town of Malta eliminating exit 11A for the present.

Presentation was given followed by discussion.

Supervisor Kinowski introduced a resolution that would need immediate action. He was contacted by Janet Kennedy who needed a Community sponsor for a Lake to Locks Grant through the Department of transportation Enhancement Program. No monetary contribution would be needed from the Town .

Now therefore be it,

RESOLVED, that the Town of Stillwater hereby authorizes and directs the Town Supervisor to execute and submit, with assistance from Lakes to Locks Passage, Inc., a reimbursable-grant application to the New York State Department of Transportation (NYSDOT) Enhancements Program for \$363,000, of which \$290,400 of Federal funds will be matched by \$72,600 of Non-Federal funds. Lakes to Locks Passage, Inc. will be responsible for securing all Non-Federal match funding so there will be no cost to the Town for the project; and be it further

RESOLVED, that the Town of Stillwater serves as the community Sponsor for this project. Staff from Lakes to Locks Passage, Inc. will provide assistance for administering

the grant and will coordinate contributions of cash and in-kind services to fulfill the obligations of the grant; and be it further

RESOLVED, that the Town of Stillwater as Sponsor of this project is willing to:

- Enter into a formal agreement with NYSDOT.
- Request reimbursement of eligible costs from NYSDOT.
- Accept responsibility for the project development in accordance with Federal requirements.
- Enter into any necessary agreement with the project applicant; and be it further

RESOLVED, that upon receipt of grant award, the Town Supervisor is directed to act on behalf of the Town of Stillwater in all matters related to this financial assistance, and is hereby authorized to execute any and all necessary contract documents.
