## Stillwater Town Board Agenda Meeting/Public Hearing

Supervisor Kinowski called the meeting to order and led everyone in the Pledge to the Flag.

7:00 PM Public Hearing (Amendment to Ethics Law)

Supervisor Kinowski called the public hearing to order.

#### **Public Input**

John V commented on Article #3 of the proposed amendments in regard to it being a violation of the state law.

Supervisor Kinowski stated it would be looked into.

Art F. inquired if everyone knew what changes where being made.

Supervisor Kinowski stated that it has been published, talked about at previous meeting and available for public inspection prior to tonight's meeting.

With no further comment Supervisor Kinowski declared the Public Hearing adjourned at 7:05 PM.

**7:05 PM Public Hearing** (*Term limits on Supervisor & Council Members*) Supervisor Kinowski called the second public hearing to order and stated that it was his intention at the end of this public hearing to adjourn the public hearing instead of closing the public hearing. He felt that this matter would need to be carried forward and keep the opportunity for residents open to comment and voice their opinions.

Jon M inquired on how term limits came about, if other communities had term limits and stated that the Supt of Highways should also be included if they were going to do term limits. Councilwoman Bruno stated that she is following up on request of residents. She feels that this would be a way of opening the process for more citizens to get involved with their communities. She is hoping to be the first Town in Saratoga County to establish term limits which will set a trend for other communities to follow.

Supervisor Kinowski commented that the Highway Superintendent position was not brought up in the general discussion of term limits

T. Mellon inquired how the term limit read and commented that they have term limits now through the election process.

Attorney Trainor read the difference between term limit for Supervisor and Council members and the term extension proposal for the Supervisor and Tax Collector positions.

Karen L. applauded the Town Board for their initiative and stated that this was an opportunity to get new blood involved. She also stated that the Highway Supt and Town Clerk elected positions should be included.

Syd T. commented about an article in the local paper, inquired if this also meant that they could not run for office again and asked if this would go up for public referendum

Supervisor Kinowski stated that the article was the view of three of the Town Board members but not necessarily how he would vote in the end, he wants to hear what the residents have to say and it boils down to want the residents want. He also indicated that the Council or Supervisor could run for another position and that this would not go up for public referendum.

Maria M. how this would affect current Board Members and would like to know the feelings of the Board Members on term limits.

Supervisor Kinowski stated that if this was to pass it would start fresh and move forward from time when they are next elected. He also commented that they were here this evening to hear from the residents and not the views of the Council Members.

Coke C. commented on the term limits and asked how this would get fresh faces when the person could run for another office.

Councilwoman Bruno stated that she believes the person should move on and not be able to run for office again.

Terry S. stated that she welcomes term limits and believes it will bring new faces and ideas to the table.

Mike C. inquired if any Board member was eligible for retirement and stated that he supported term limits and the increase of term extension for the Supervisor.

Supervisor Kinowski stated that the present Town Board was not eligible for retirement.

John B. stated that he & his wife supported term limits.

Keith C. supports term limits, felt it would bring fresh ideas and that it should be Town wide and include all elected officials. He also inquired if this would hinder the Supervisor at the County level.

Supervisor Kinowski stated that this would not affect the Supervisor at the County level.

Councilman Petronis stated that he has been around a long time and he doesn't believe in term limits. He commented on a letter received from former Supervisor Connelly who stated people fought wars to give us the right to vote for the person they want in office. He stated that there was no way he was going to vote in favor of this proposal. Anyone has the right to run for office through the election process and he is not going to take peoples rights away from them.

Supervisor Kinowski wanted it known that Councilman Petronis may not be in favor of the term limits but agreed to go forward with the public hearing to discuss the proposal.

Art F. stated that he was not in favor of term limits.

Phil C. inquired on how the Supervisor felt about term limits.

Supervisor Kinowski stated that he was for term limits and if anyone wanted they could come to his office and he will discuss it with them one on one.

John V. stated that he was against term limits.

Fran B stated that he agreed with Councilman Petronis and that they have always had term limits through the election process. He commented that if someone is doing a good job for the Town the residents will see that and if not then they will be voted out. He also felt that term limits could hurt the town.

Supervisor Kinowski commented that some people feel they know the outcome of this proposal but he feels that this needs a lot more input from the general public. They have had discussions on how to reach people and suggestions such as surveys in the tax bill, e-mails etc. He feels they need more time to discuss this matter and if anyone has any suggestions on how to reach the residents don't hesitate to submit them.

Discussion was held on whether this could be put on the ballot for election. It was noted that it can not be put to vote on the ballot because there was know legal authority. It was mentioned that a citizen referendum could be done by petition to be placed on the ballot.

With no further comment Supervisor Kinowski declared the Public Hearing adjourned at 7:55 PM.

### **Business Meeting** 8:00 PM

Supervisor Kinowski called the Business meeting to order.

Town Clerk, Sue Cunningham took the roll call.

<u>Adoption of Minutes:</u> <u>Motion</u> by Councilwoman Whitman and seconded by Councilman Petronis to adopt the minutes of the August 19, 2010 Business Meeting. <u>Motion carried.</u>

Supervisor Kinowski reported that he attended the dedication of a 100 acre walking trail park in the Luther Forest which includes woodlands, swamplands, bridges and overlooks. He stated that it is accessed by Route 9 or off Route 67. He also commented that there was another trail up near the Wilton Mall near BJ's which consists of seven miles of trails.

## **Public Input**

Mike C. inquired about resolution #88.

Supervisor Kinowski stated that the agenda & business meeting will be held on October 7<sup>th</sup> in order for the Town Board to hold several budget workshops if necessary.

John Basile, Village Trustee spoke on the Town sewer units serviced by the Village, the fine imposed on the Village by DEC and repairs that needs to be made to the Castle Cliff Sewer Plant.

Terry S. inquired about the financial status of the multi use trail and the Glen Hollow Park. Supervisor Kinowski stated that on the matter of the trail they will be discussing that at budget time on how to pay the debt. In regard to the Glen Hollow Park he has met with residents, Engineer Lanaro, and Supt Minick and they are moving forward in phases in the most cost effective way.

Karen L commented on ditch digging, stockpiling good top soil and herbicides in the soil. She was not in favor of irrigation systems in the park for cost effective reasons. Discussion was held on soil and grass.

Art F. inquired about the cost relating to Resolution #83 & #84.

Supervisor Kinowski stated that for Resolution #84 it is funded by an escrow account that the developer funds and for #83 it is a volunteer position.

Mike C inquired if the Kaboom grant was received or awarded to the Town.

Supervisor Kinowski spoke on the committee involved in trying to obtain the grant, having a secure location to be utilized for the playground equipment and since the park is not ready yet the Stillwater Area Community Center is a starting point.
