Now, therefore, be it

RESOLVED, that Edward Kinowski, as Supervisor of the Town of Stillwater is hereby authorized and directed to file an application for funds from the New York State Office of Parks, Recreation and Historic Preservation in accordance with the provisions of the Recreational Trails Program, in an amount not to exceed \$200,000.00, and upon approval of said request to enter into and execute a project agreement with the State for such financial assistance to the Town of Stillwater for Campbell Park Trailhead and extension of the Stillwater Historic Multi-Use Trail, and, if appropriate, a conservation easement to the deed of the assisted property.

Budget Message

Supervisor Kinowski explained his approach to preparing the budget. He started by asking Department Heads what they wanted, involved redistribution of sales tax and that this is only a working budget in which three workshops will be scheduled to start chiseling away to bring down the tax increase. He also commented on the presentation of the budget which will now show all cash on hand, all unallocated and unappropriated fund balances.

Councilwoman Bruno stated that she likes the way the budget was prepared and feels that if the Town Board works together as a team they can come up with an acceptable budget.

Public Input

Syd T. stated that Social Security is fixed income with no pay increase and people on SS can not afford the increase proposed in the budget.

Jim C inquired on the status of the Doughty Landfill, the lawsuit with Mechanicville School Dist. and the Boilerhouse expense to the taxpayer.

Attorney Trainor stated that the Doughty Landfill is still open with DEC but there has been no movement and there is no resolve with MSD but it is moving forward.

Supervisor Kinowski stated that he is still researching this and needs more time before he can answer questions regarding this matter.

Terry S questioned the Campbell Rd Trailhead in regard to parking & design and the Omnibus Loan.

Engineer Lanaro stated that there is no official design yet. They just need to prepare a concept plan to get the grant and after funding is approved they will do a final concept plan.

Supervisor Kinowski stated that he is looking at what money was received, how the money was applied and if it was applied correctly.

Art F. inquired where the Brownfields were and commented on the term limits.

Supervisor Kinowski stated that the current Brownfield was the old smokestack on Best Ave. Supervisor Kinowski stated in regard to term limits they still need a fair way of resolving their vote and more input from the public was needed in order to do that.

Tom M commented on term limits as to where a petition can be obtain & how to go about doing a resident referendum.

Attorney Trainor stated that there is a provision in the Town law under Municipal Home Rule section #36 & 37.

Supervisor Kinowski stated that he would obtain the information needed and see that the resident receives it.

Discussion was held on how to best survey the Town residents on their views of term limits for the Supervisor and Council Members.

Art G inquired why department heads did not come to the Board meetings to give reports or answer questions from the public and if the Community Center requested money from the Town to pay for their oil bill.

Supervisor Kinowski he will ask department heads about coming to the meetings and they will discuss at budget time appropriating money for the Community Centers oil bill.

Supervisor Kinowski stated that the new Community Center Director will be attending the 1st Town Board meeting in November.

Supervisor Kinowski stated that the water ban has been lifted for Water District #3 & #4 and on October 13th the City of Mechanicville will be having a meting at the Senior Center to discuss the water situation.
