Councilman Baker

<u>Events:</u> Councilman Baker requested that they increase money budgeted for the reenactors from \$50 to \$250 for the events they provide for during the year.

A brief discussion was held on this with the consensus that they could just do a Motion to increase the amount and at budget time they can consider budgeting a higher amount. <u>Motion</u> by Councilman Baker and seconded by Councilman Petronis to increase amount given to the re-enactors from \$50 to \$250. <u>Motion carried.</u>

<u>Ladies Night:</u> Councilwoman Bruno reported that the October 18th is Ladies Night out held by the Stillwater Library.

<u>Fall Festival:</u> Councilwoman Bruno that the Library will be holding the 2nd annual Fall Festival throughout the Village on October 26th.

<u>Global Foundries Fab 8.2:</u> Councilwoman Whitman inquired if they would be giving Stillwater funds when they are approve and upon completion. Supervisor Kinowski stated that immediate on approval.

<u>Glen Hollow Park:</u> Supervisor Kinowski gave a brief update on the progress of Glen Hollow Park. At this time the picnic area done, cookers are in, and by the end of the year the field and tennis court should be completed. Next year the basketball court and parking should be completed.

<u>Tax Auction property:</u> Supervisor Kinowski reported on the property the Town was purchasing from the tax auction for back taxes. He went over the process that needs to be followed before the land belongs to the Town.

<u>Old Town Hall:</u> Supervisor Kinowski spoke on a potential use of the old Town Hall. Possibly the Town Police Dept. utilizing a portion of the Town Hall and the Historian utilizing the other portion.

<u>Boilerhouse property:</u> Supervisor Kinowski stated that they may need a possible resolution for the November meeting regarding the DeCrescente request.

<u>MHP Moratorium</u>: Supervisor Kinowski stated that a potential moratorium on MHP has been suggested and they need to look at the legalities.

RESOLVED, that the Town Board, acting as lead agency for the coordinated SEQRA evaluation of the proposed Zoning Map Amendments hereby determines that the proposed action is a Type II action and will not have a significant environmental impact pursuant to 6 NYCRR Part 617.5(17) (SEQRA); and be it further

RESOLVED, that the Town Board authorizes the dissemination of the Notice of Determination of Non-Significance to all involved and interested agencies.
