# Resolution #23 Authorizing Awarding a Contract to Install Carpet in the Stillwater Area Community Center (SACC) Office for \$2500 as Budgeted

WHEREAS, the carpet in the office at the Stillwater Area Community Center ("SACC") is in need of replacement; and

WHEREAS, there are already budgeted funds for the repair or replacement to the carpet in the Stillwater Area Community Center;

Now, therefore, be it

RESOLVED, that the Town Board hereby authorizes the Supervisor to enter into a contract with Glens Carpet for the amount of \$2500.

<u>Motion carried.</u> Resolution No. 23 of 2017 was adopted unanimously.

Supervisor Kinowski informed the public that our bookkeeper, Colleen Zabielski had unexpectedly passed away. A moment of silence was observed. He also informed the board that an advertisement to newspapers was submitted to newspapers in search of a new bookkeeper. Someone would be hired provisionally until a civil service test was taken. Resumes are being accepted to the Town Clerk until May 12, 2017.

Supervisor Kinowski also mentioned that the town is searching for committee members. Committee members from different neighborhoods and backgrounds that would bring different ideas to the table on different studies conducted within the town. He is looking for volunteers. Candidates should be available to meet for meetings of 1 to 4 hours.

At this time, Supervisor Kinowski asked Attorney Trainor to explain simplified changes in the PDD process. Due to our capable Building, Zoning and Planning department, meeting with applicants upfront, steps can be cut out. This revised process should save the town time and money. It will be suggested to Planning Board at their next meeting and go to Public Hearing if it moves forward.

Councilwoman Vomacka gave a short report on the Emergency Management meeting. They would like to provide cards with emergency numbers to the public.

Supervisor Kinowski reminded her that there is money in their budget to possibly make magnets. There is an opportunity to distribute at events like Family Day.

Councilwoman Bruno also suggested that some be given to the Town Clerk in the Welcome Folders that she distributes.

Councilwoman Vomacka also reminded everyone that Open House at Arvin Hart is on sat April 29, 2017 11-2.

Councilwoman Bruno informed everyone that the legion is having a band on April 28, 2017 form 7-10 and will have more Friday concerts in future.

Attorney Trainor requested Executive Session to discuss litigation.

Supervisor Kinowski also informed the public of changes with adding water customers on County Route 76 with the Village. A short discussion was held.
