WHEREAS, James Doyle commenced an Article 7 real property tax protest for 13 parcels within the Town of Stillwater for the 2016 assessment on those properties; and

WHEREAS, the parties have reached a proposed settlement regarding 8 of the 13 parcels in question; and

WHEREAS, the action for the remaining 5 parcels shall continue; and

WHEREAS, the settlement for 6 of those 8 parcels would be as follows:

Resolution #26 Expenses Incurred for the Demolition of 3 Dorchester Drive

WHEREAS, the Town Board previously authorized the demolition of 3 Dorchester Drive on January 19, 2017 by adopting Resolution No. 7 of 2017; and

WHEREAS, the demolition was completed by the Highway Department on February 2, 2017; and

WHEREAS, Local Law 6 of 2004 and Section 69-11 of the Stillwater Town Code permit the expenses to be added to the property's tax bill 30 days after its billed to the owner and remains unpaid; and

WHEREAS, multiple grounds exist in both State Law and the common law to pursue the payment of the Town's demolition expenses through legal proceedings as well;

Now, therefore, be it

RESOLVED, that the Town Board hereby approves the attached invoices for expenses related to the demolition of 3 Dorchester Drive in the amounts of \$15,016 to the Town Highway Department, \$5,099.25 for the Town as reimbursement of legal expenses through March 30, 2017; and be it further

RESOLVED, That the Town Board hereby directs the Attorneys for the Town to invoice and demand payment from owners, lienholders and other legal interest holders of 3 Dorchester Drive for the total demolition related expenses of \$20,115.25 through March 30, 2017; and be it further

RESOLVED, that if the invoiced demolition expenses for 3 Dorchester Drive remain unpaid after 30 days, the Town Assessor shall transmit the account of this unpaid expense to the Treasurer of Saratoga County, who shall assess the total amount of unpaid expenses against the land and cause the unpaid expenses to be levied and collected in the

same manner as provided in Article 15 of the NYS Town Law for the levy and collection of a special and valorem levy; and be it further

RESOLVED, that the Attorneys for the Town are hereby authorized to commence appropriate legal actions against the owners, lienholders and other legal interest holders of 3 Dorchester Drive for recovery of all of the Town's costs related to its demolition and cost recovery if the aforementioned invoice for total expenses through March 30, 2017 remains unpaid for more than 30 days.
