Resolution #32 Summer Scheduling of Town Board Meetings for 2017

WHEREAS, both the Building Department's engineer and the attorney for the Town have reviewed the application and proposed PDD amendments, have provided their comments to the applicant and the applicant has responded thereto in writing; and

WHEREAS, the appropriate changes have been proposed to the existing PDD language to incorporate condominiums but also the engineer's and attorney's comments; and

WHEREAS, a Public Hearing was conducted on May 18, 2017 but significant changes have been proposed to the Public Benefit portion of the Local Law;

Now, therefore, be it

RESOLVED, that the application by Lansing Engineering PC and Amedore Homes regarding the amendment of the Winding Brook Planned Development District (Ordinance No. 2 – 1993 and Local Law 5-2012) be scheduled for a Public Hearing on June 15, 2017 at 7:10PM at the Town Hall, 881 Hudson Avenue, Stillwater, New York; and be it further

RESOLVED, that pursuant to the authority vesting in the Town Board by virtue of the New York State Constitution and the Municipal Home Rule Law, the Town Board hereby exercises its authority to supersede New York State Town Law Sections 264 and 265 requiring ten (10) days prior publication of the Public Hearing and shortening the period to five (5) days prior to the hearing pursuant to Municipal Home Rule Law Section 20; and be it further

RESOLVED, that the Town Clerk is directed to immediately post and publish the attached Notice of Public Hearing in the Schenectady Gazette or the Mechanicville Express preferably ten (10) days prior to June 15, 2017 but no later than five (5) days prior to June 15, 2017 and to obtain Affidavits of Publication therefore; and be it further

RESOLVED, that the Town Board exercises its authority pursuant to §20 of the Municipal Home Rule Law to waive the requirements of Town Law §264 and §265 and Stillwater Town Code Chapter 210 §138, to mail individual notices of the Public Hearing with a copy of the proposed zoning changes to residents affected by the Winding Brook PDD Amendment, not less than 10 days before the Public Hearing; and be it further

RESOLVED, that the Town Clerk shall complete and file in the Office of the Town Clerk the attached Affidavits of Posting/Publication, not later than June 15, 2017; and be it further

RESOLVED, that the Town Clerk shall submit a copy of the proposed Local Law of 2017 with attachments to the Town Planning Board; and be it further

RESOLVED, that the Town Board has reviewed Part I of the project's Environmental Assessment Form and declares itself the appropriate Lead Agency to consider the environmental impacts of the project; and be it further

RESOLVED, that the Director of Building and Planning is hereby directed to immediately refer the proposed Zoning Code Amendments to the Saratoga County Planning Board pursuant to Section 239-m of the General Municipal Law, respectively, for its review and recommendations prior to June 15, 2017; and be it further

RESOLVED, that the Director of Building and Planning with the assistance of the Chazen Companies, shall ensure compliance with NYS Agriculture & Markets Law Articles 25-AA, 25-AAA, especially Section 305-a thereto, and also ensure that the

requirements of the State Environmental Quality Review Act ("SEQRA") and complied with.
