Inc. instead of its transfer to the Town of Stillwater; and be it further

Public Input

James F. Sr. commented on the proposed PDD for Saratoga Hills in regard to drainage, flooding, road going in and traffic.

Supervisor Kinowski stated that all his concerns must meet State mandates and would be addressed through the MS4 & SEQR process.

James F Jr. stated that he has questions regarding their proposal, he is opposed to the proposal and would like to see the Town Board deny the proposal, he sees no benefit to the Town and feels they should continue to improve the park not expand it.

Supervisor Kinowski stated that they are not increasing the park, they are cutting down the number of trailers by bringing new trailers in that are up to code, creating more parking and tax assessment is increasing not decreasing.

Julie W inquired on the status of the PDD amendment proposals, who is involved, who the Building Dept. & Engineer report to and notification process of public hearings. Supervisor Kinowski stated they are reviewing the proposed change. The Town Board, Planning & Zoning Board and Building Dept. are reviewing comments and proposed changes. They are not ready yet to bring it back to the public. The building Dept. & Engineer report to the Town Board or to himself on a daily basis. As for notifications there is a legal process that we are required to follow.

Ken O inquired as to the construction at Brown's Beach.

Supervisor Kinowski gave a brief overview of the construction plans.

Dick D inquired on the status of the speed reduction request for County Rd 76 from the four corners up to Grace Moore Rd.

Supt Minick stated that he knows the State was doing status work a couple of months ago. He has not heard of what the results were yet.

Supervisor Kinowski stated that he has heard nothing but would put a call into DOT.

Linda B inquired if a formal application was submitted on a PDD.

Supervisor Kinowski stated that no formal package has been submitted.
