

Resolution #26

Temporarily Waive the Town Noise Ordinance
for a One Time Event

Introduced by: Supervisor

WHEREAS, the Town currently has a noise ordinance in place restricting the decibel level from 7:00 am to 11:00 p.m., on Friday and Saturday to 75dBA; and

WHEREAS, a one-time event is scheduled for Brown’s Beach to host a “Battle of the Bands” competition and the event will go until 11:00 p.m. on Saturday, July 9, 2016;

WHEREAS, the concert will require a temporary waiver of the noise ordinance limits for this one-time event due to the decibel level surpassing the 75dBA level but no louder than 120dBA level.

Now, therefore be it

RESOLVED, that the Town Board hereby waives the noise ordinance for a one-time event scheduled for Saturday, July 9, 2016 at Brown’s Beach titled “Battle of the Bands in order to allow the decibel level to exceed 75dBA, up to a maximum of 120 DBA, until 11p.m. that evening.
