WHEREAS, the Town of Stillwater has reviewed its housing and community development problems and needs, and has developed a proposed program and application for grant funds.

WHEREAS, the OCR application process requires that the governing body of the application authorize the submission of the application and related actions; and

RESOLVED, that the Town Board hereby authorizes and directs the Supervisor to submit the application to OCR and to act in connection with the submission of the application, including execution of all required certifications and forms and to provide such additional information as may be required; and be it further

RESOLVED, that the Supervisor is authorized to contribute \$75,000 of Town funding total toward the project cost to replace the water main in the West and Micklas Streets neighborhoods of Water District 1 at the South end of the Town.
