WHEREAS, the Town Board has compared the proposed action with the criteria for determining significance in SEQRA 6 NYCRR 617.7 and has duly considered the Short Environmental Assessment Form previously prepared by the Chazen Companies when Water District 5 Ext 1 was formed in 2016, a copy which is on file in the Town Clerk's Office; and

WHEREAS, the Amended Map, Plan and Report dated January 16, 2019 indicates no significant environmental impacts since 2016 as a result of the proposed extension of district boundaries; and

WHEREAS, a Public Hearing was conducted at the Town Board meeting on February 21, 2019 at which time the environmental impacts of the project were presented and discussed; and

Now, therefore, be it

RESOLVED, that the Town Board has determined that the proposed Extension of Water District #5, Extension 1 is an Unlisted Action pursuant to 6 NYCRR Part 617 (SEQRA), has determined that an Uncoordinated Review is appropriate, finds pursuant to the criteria in Part 617.7 that the proposed action will not have an adverse environmental impact and hereby issues a negative declaration.

WHEREAS, the Town Board has reviewed the Map, Plan and Report prepared by the Chazen Companies dated January 16, 2019, a copy of which is attached hereto and is on file in the Town Clerk's Office for public inspection, providing for the extension of Boundaries of Water District #5 Extension 1; and

WHEREAS, a Public Hearing was conducted by the Town Board at its regularly scheduled meeting of February 21, 2019 regarding the extension of the boundaries of Water District #5 Extension 1 pursuant to Article 12-A of the Town Law, as well as the potential environmental impacts of the same, and the public was given the opportunity to comment thereon; and

WHEREAS, the attached Map, Plan and Report provides a description of the extension of boundaries of Extension 1 to Water District 5, the improvements proposed, the maximum amount to be expended, the proposed method of financing and the environmental significance thereof;

NOW, therefore be it

RESOLVED that the Town Board makes the following findings and conclusions pursuant to Article 12-A of the Town Law:

- 1. That the Notice of Public Hearing was published and posted as required by law and is otherwise sufficient;
- 2. That all the property and the property owners included within the proposed extended District are benefited thereby;
- 3. That all the property and the property owners benefitted are included within the limits of the proposed extended District;
- 4. That the establishment of the extended District Extension is in the public's interest;
- 5. That the expenses for the formation of the extended District Extension and the construction of any water improvements shall be assessed, levied and collected on a benefit basis from the owners within the extended District;
- 6. That the establishment of the extended District Extension and any construction of water system improvements required for it are hereby approved at a cost to the extended District of \$515 Total Annual Cost per Typical Single Family Home;
- 7. That following a review of the Short Environmental Assessment Form and after due deliberation thereon, the Town Board conducted an Uncoordinated Review of the Unlisted Action and issued a Negative Declaration (Determination of Non-Significance) pursuant to the provisions of Article 8 of the New York Environmental Conservation Law; and be it further

RESOLVED that the extension of boundaries of Water District No. 5, Extension 1 is hereby approved, and the District is wholly situated outside of any incorporated Village or City and bounded and described as follows: The amended service area includes properties along Lake Road (CR 76), Dunn Road, and Dick Lynch Road, as well as the Saratoga Hills Mobile Home Park (Saratoga Hills Park), and several properties located along Colonial Road outside of the Village's service area (e.g. Village corporate limits); and be it further

RESOLVED that submission of an application for approval to the State Comptroller is not required as the cost to the typical homeowner is estimated at \$515 per year, far below the 2019 Comptroller's threshold requiring Comptroller approval of \$898 per year; and be it further

RESOLVED that within 10 days after the adoption of this Resolution, the Town Clerk shall record with Clerk of the County of Saratoga and file in the Office of the State Comptroller, copies of this Resolution certified by the Town Clerk.

Resolution #18 Approving the Settlement for McBride v. Town of Stillwater, Real Property Tax Assessment Challenge, Residential Property

WHEREAS, Michael McBride owns property at 64 Brickhouse Road. It was assessed for \$145,000.00 (Fair Market Value: \$154,700.00.) Mr. McBride challenged the assessment and sought an assessed value of \$60,000.00; and

WHEREAS, the exchange of appraisals resulted in valuations as follows:

	<u>FMV</u>	Assessment Value
McBride's Appraisal	\$110,000.00	\$ 99,000.00
Town's Appraisal	\$170,000.00	\$153,000.00
Average Between the 2 appraisals:	\$140,000.00	\$126,000.00; and

WHEREAS, Mr. McBride is willing to accept a settlement valuation of \$127,072 (FMV) which is an assessed value of \$115,000.00. This would result in a \$25,000.00 decrease for the assessed value of the property at issue. With a tax rate of approximately 4.5% per thousand, this amounts to a net loss in tax revenue to the Town of approximately \$112.50; and

WHEREAS, Real Property Tax Law §727 shall apply which governs the duration of the new equalization rate; and

WHEREAS, this settlement proposal has the support of the attorneys for the town and of the town assessor.

NOW, therefore be it

RESOLVED, that the Town Board accepts the proposal and authorizes the attorneys for the Town to prepare and execute the settlement documents.
